

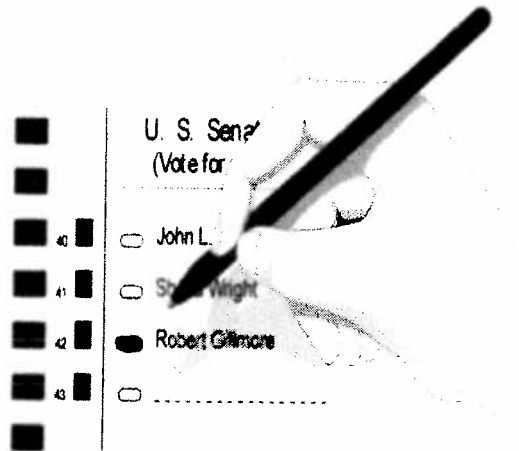
INSTRUCTIONS TO ABSENTEE VOTERS

MAKE YOUR VOTE COUNT

FIRST, LOOK OVER THE BALLOT AND DECIDE HOW YOU WANT TO VOTE. MARK YOUR BALLOT IN SECRET.

MARK YOUR BALLOT ONLY IN THE MANNER DESCRIBED BELOW (See Diagram):
Read these instructions carefully before mailing ballot.

TO VOTE, FILL IN THE OVAL COMPLETELY USING A BLACK MEDIUM BALLPOINT PEN.
DO NOT X, DO NOT ✓, DO NOT CIRCLE. FILL IN THE OVAL.



1. MARK BALLOT — USE A BLACK MEDIUM BALLPOINT PEN.

DO NOT ERASE!

2. PLACE YOUR BALLOT IN SECRECY ENVELOPE. (**DO NOT PLACE IDENTIFICATION IN THIS ENVELOPE.**)

3. PLACE SECRECY ENVELOPE (WHICH CONTAINS YOUR BALLOT) IN AFFIDAVIT ENVELOPE .

4. SEAL YOUR AFFIDAVIT ENVELOPE (WITH YOUR BALLOT INSIDE). COMPLETE AND SIGN THE AFFIDAVIT ON THE BACK OF THE ENVELOPE. YOU MUST EITHER HAVE YOUR SIGNATURE NOTARIZED OR HAVE TWO WITNESSES SIGN YOUR AFFIDAVIT.

5. PLACE AFFIDAVIT ENVELOPE INSIDE THE LARGE BROWN ENVELOPE **ALONG WITH A COPY OF PROPER IDENTIFICATION.** YOU WILL FIND A LIST OF ACCEPTABLE FORMS OF IDENTIFICATION ON THE BACK OF THIS INSTRUCTION SHEET. DO NOT PUT YOUR IDENTIFICATION INSIDE THE BALLOT SECRECY ENVELOPE OR THE AFFIDAVIT ENVELOPE!

6. MAIL OR HAND DELIVER THE LARGE BROWN ENVELOPE WITH YOUR BALLOT AND COPY OF IDENTIFICATION ENCLOSED TO THE ABSENTEE ELECTION MANAGER.

ATTENTION: Pursuant to Code of Alabama, Section 17-9-30(a), one of the following forms of identification is required in order for you to vote.

- (a) a valid Alabama driver's license which was properly issued by the appropriate state or county department or agency;**
- (b) a valid Alabama nondriver identification card which was properly issued by the appropriate state or county department or agency;**
- (c) a valid Alabama photo voter identification card;**
- (d) a valid identification card issued by a branch, department, agency, or entity of the State of Alabama, any other state, or the United States authorized by law to issue personal identification, provided that such identification card contains a photograph of the elector;**
- (e) a valid U.S. passport;**
- (f) a valid employee identification card containing the photograph of the elector and issued by any branch, department, agency, or entity of the U.S. government, the State of Alabama, or any county, municipality, board, authority, or other entity of this state;**
- (g) a valid student or employee identification card issued by a public or private college, university, or postgraduate technical or professional school located within the State of Alabama, provided that such identification card contains a photograph of the elector;**
- (h) a valid U.S. military identification card, provided that such identification card contains a photograph of the elector; or**
- (i) a valid tribal identification card containing a photograph of the elector.**

You can use this form to:

- ▶ Register to vote in Alabama.
- ▶ Update your voter registration record, if you have changed your name or address.

To register to vote in the State of Alabama, you must:

- ▶ Be a citizen of the United States.
- ▶ Reside in Alabama.
- ▶ Be at least 18 years of age on or before election day.
- ▶ Not have been convicted of a disqualifying felony, or if you have been convicted, you must have had your civil rights restored.
- ▶ Not have been declared "mentally incompetent" by a court.

Deadline for submitting application:

Voter registration and updating of voter records is closed during the ten days prior to each election in Alabama.

ID requested: You may send with this application a copy of a current and valid photo identification, government check, paycheck, or other government document that show your name and address. You will be required to present identification when you vote absentee or at your polling place.
